Explanation of Responses:

1. In connection with the offering (the "Offering") of ordinary shares, no par value (the "Ordinary Shares") of Avago Technologies Limited ("Avago"), the reporting persons, as a selling shareholder, sold 1,073,047 shares of Ordinary Shares. The Offering closed on October 3, 2011.
2. This report is filed jointly by the reporting persons. Each of the reporting persons is a Singapore private limited company and they share the power to vote and dispose of these securities. No individual has beneficial ownership over these securities. Voting and investment decisions relating to these securities are made by the GIC Special Investments Pte. Ltd. investment committee, which is currently comprised of nine members: Tay Lim Hock, Ng Kin Sze, Kunna Chinniah, Ang Eng Seng, Eugene Wong, John Tang, Choo Yong Cheen, Stuart Baldwin, and Suzi Cohen. The investment committee acts by majority vote and no member may act individually to vote or sell these securities. Beneficial ownership is disclaimed by the investment committee and each of its members. Each of the reporting persons disclaims beneficial ownership of these securities, except to the extent of its pecuniary interest therein.
3. Geyser, Seletar Investments Pte Ltd, Bali Investments S.a.r.l., certain affiliates of Kohlberg Kravis Roberts & Co. and certain affiliates of Silver Lake Partners are parties to a shareholders agreement with respect to the Ordinary Shares, and solely as a result of which each such person may be deemed to be a member of a group with respect to the Ordinary Shares of Avago held directly or indirectly by such persons. Geyser disclaims beneficial ownership of such Ordinary Shares, except to the extent of its pecuniary interest therein.
