Geyser, GIC Special Investments Pte Ltd and the Government of Singapore Investment Corporation Pte Ltd each disclaim membership in a group.

Gevser, Seletar Investments Pte Ltd, Bali Investments S.a.r.l., certain affiliates of Kohlberg Kravis Roberts & Co. and certain affiliates of Silver Lake Partners are parties to a shareholders agreement with respect to certain Ordinary Shares of the issuer (including the Securities), solely as a result of which each such person may be deemed to be a member of a group with respect to the Ordinary Shares of the issuer held directly or indirectly by such persons. However, each such person disclaims membership in any such group and disclaims beneficial ownership of the Ordinary Shares of the issuer, except to the extent of its pecuniary interest therein.
